Subject: Recognition of Private Schools.

Government Order No. ¹⁷⁶ Edu of 2016
Dated: 19-05-2016.

1. Whereas 36 cases of extension /upgradation of private educational institutions have been approved by the Affiliation Committee of the JKBOSE in its meeting held on 29-04-2016 as per the details below -
 - i. 03 and 06 (Total 09) cases, listed in Annexure "A", in respect of Jammu and Kashmir Division respectively which were found to be clear in all respects.
 - ii. 07 and 11 (Total 18) cases, listed in Annexure "B", in respect of Jammu and Kashmir Division respectively, which have to make up such deficiencies that do not require construction or major procurements or alternative arrangements.
 - iii. 02 and 07 (Total 09) cases, listed in Annexure "C", in respect of Jammu and Kashmir Division respectively, which have minor infrastructural deficiencies and the management has either addressed them or has assured to do so in one to three months.
2. Therefore, taking into account the approval granted by the Affiliation Committee, schools shown in Annexure "A", "B", & "C" are hereby granted recognition, co-terminus with the period of affiliation granted by JKBOSE. These schools shall ensure:-
 - i. Compliance to the conditions prescribed in the NOCs, issued by the competent authorities and in particular, the NOC conditions imposed by the Traffic Department pertaining to safe transportation of children, boarding/de-boarding arrangements and deployment of personnel, for the purpose & also formulation of proper traffic management plan.
 - ii. Strict compliance to the directions/decisions of the Committee for Fixation of Fee structure constituted by the Government.
 - iii. Adherence to terms and conditions of affiliation order issued by JKBOSE.
